Art. 1. - E 'consists of the Association called "inter-European People's Economic Social Movement". It is a free association of fact, with unlimited duration and non-profit, regulated under Title Cap. III, art. 36 et seq. the Civil Code and of this Statute. The association is directly and exclusively affiliated with the "FOUNDATION OF FRANCESCO TERRONE RIPACANDIDA AND BROOM ETS" based in Rome. Registered office of the Movement via Ada Negri, 30 - int. 9 / B Nomentana - Rome.

Art. 2. - The Association Movement Economic Social People's inter-European pursues the following purposes:

- · Spreading the culture, in all its forms and applications, freely and independently
- Listen to the most common needs of the citizens and bring them by proposals for laws supported by appropriate popular petitions to the political tables, making use of the legislative instrument offered by 'art. 71 of the Italian Constitution.
- Promoting a free and independent debate on social issues, political, cultural, economic and philosophical, allowing the free formation and the free development of their ideas and positions
- Promote the confrontation of different political and ideological considerations, in a democratic environment and mutual respect, the basic consideration that the dialogue is a fundamental value for the development of a free and advanced society.
- Combating all forms of discrimination struggling for each citizen has equal opportunity and enjoy the same rights, stating at all times and under all circumstances the principle of equality established by article 3 of the Constitution. Italian, and Chapter III of the Charter of Fundamental Rights' European Union.
- Working in different areas of the company with the consideration not only be Italian nationals, but European, remembering and affirming the importance of the process, still under way, the formation of a 'Union more political and less formal, which operates, while taking always present the diversity and national peculiarities, with wider powers to establish itself more firmly as the main actor in different global scenarios.
- Offer the opportunity for all young people, and not only that, through various activities, to give voice to ideas, opinions, expectations and dreams, convinced that everyone, in a free and democratic country, should have, with respect for others, the ability to to express themselves. We consider communication a fundamental tool when free and independent, to start a healthy process of change that starts from the formation of a critical conscience and active
- Create opportunities to meet and socialize with boys, to also give the possibility, if missing, to find space to discuss and meet, to organize and take action in the various activities, to offer an alternative to the street to many young people of the territory.
- Monitoring of national media to counter 'image often negative of the people of' Central and Southern Italy, Southern and its cultural traditions.
- Create the South a platform that gives centrality to existing and future resources of the Territory in a logic of interchange National, Regional and Global.

The movement rejects war and violence in all its forms. It banishes any ideology that uses violence as a way to substantiate its claim and that it is contrary to Italian laws, Community and international agreements. In accordance with the fundamental rights of individuals and with what has been claimed, each of the movement activity will be conducted in full respect of possible different positions,

considering the diversity of views is not an obstacle but a resource for the development of society and for cultural and personal growth of the individual.

- Art. 3. The Movement for the achievement of its purposes, aims to promote various activities, in particular:
- Cultural activities: conferences; conferences; debates; seminars; film club; concerts; theater show; activation of an Internet site that contains case studies, reports, surveys, various sections and activities related to the work of the Movement; development of a web radio; any other activity over time is deemed necessary for the implementation of the above mentioned purposes.
- Political activities: collecting signatures; awareness-raising activities; use of instruments of direct democracy provided by our legal system to highlight and resolve issues considered fundamental; any other activity, provided according to the Regulations, it is deemed necessary in time for the implementation of the above mentioned purposes.
- Training activities: establishment of centers of study, research and training, development of schools of thought, policy simulations.
- Social activities: organization of meetings and sports tournaments. To achieve its purpose, the Movement adopts a democratic, based on free discussion and comparison. The movement can collaborate with cultural and scientific institutions, national movements, European or international that pursue similar purposes.
- · award of scholarships to Italian students and students of different nationalities.
- Art. 4. Members receive a membership card that certifies the membership, these are required to pay an annual fee for which an indicative amount will be determined by the National Governing Council, 5% of this amount will be paid annually to the franchisor Foundation for the coordination activities and rights on the activities carried out by the movement, while the remaining 95% will be used to finance the activities of the movement itself.

Entries can be send directly to the National Secretariat for the inclusion of special form or via the platform "Vesuvius".

The members are divided into

Ordinary members: persons or entities who agree to pay for the entire stay of the associative link, the annual fee established by the National Council;

Founders: people, organizations or institutions that have contributed in a decisive manner, through their work or their generous support that statement under the association's constitution.

Honorary members: persons, organizations or institutions that have distinguished themselves in the cultural, social, political and economic, and not only in our country, with works and ideas consistent with the principles of this association and confirmed in this statute. Honorary members are exempt from paying the annual dues. The honorary membership status may be proclaimed by a qualified majority of ¾ Assembly at the request of the president, the board or at least ¼ of the assembly members. The purchase of that status and what it entails is subordinated to the will of the person concerned. Each member is entitled to vote and is free to propose any initiatives in the Assembly, provided they comply with the principles contained in the present Charter.

Any new member shall be submitted at least two shareholders registered shareholders by not less than two years. In the first two years of life on the prospective members must have the approval of the National Governing Council.

Members can also be residing at 'Foreign and different Nationalities.

- Art. 5. Whatever Italian and European citizen, not under the age of eighteen can join the Movement. In the occurrence of the inscription declaring to share the principles, purposes and the movement status and it sticks faithfully. If the subject had already shown prior to enrollment attitudes or positions contrary to the principles and purposes established by this association and confirmed in this Statute, the Governing Council may refuse admission by voting unanimously. Against the refusal of admission shall be subject to appeal within 30 days, the Board of Arbitrators.
- Art. 6. All members are required to comply with the provisions of this statute and any rules, according to the resolutions passed by the competent bodies. For diverging behavior which is prejudicial to the purposes and the assets of the National Governing Council should intervene and impose the following sanctions: recall, warning, expulsion of the Association. The expelled member may appeal in writing against the decision within thirty days to the Board of Arbitrators.
- Art. 7 All members have the right to vote for the approval and modification of the statutes and regulations, and for the appointment of the governing bodies of the association. The right to vote can not be excluded even in case of temporary participation in community life.
- Art. 8. The movement of economic resources consist of: property, real estate and furniture contributions, donations and bequests, repayments marginal activities of commercial and productive; any type of revenue. The contributions of the members shall be the annual membership fees, and any extraordinary contributions established by the National Executive Council, which determines the amount. Donations in cash, donations and legacies, are accepted by the Assembly, which decides on the use of them, in harmony with objectives statuary organization. And 'forbidden to distribute, even indirectly, profits or operating surpluses as well as funds, reserves or capital during the life of the Movement, unless the use or distribution is required by law.
- Art. 9. The financial year begins on January 1 and ends on December 31 of each year. The Governing Council shall prepare, in cooperation with the treasurer, the budget and the final balance. The budget and final accounts should be approved by the Ordinary annually by April. It must be deposited at the headquarters of the Movement within the 15 days prior to the session in order to be consulted by each member.
- Art.10. The Movement may, at the decision of the National Executive Board, delegations throughout the country and the European Union. The individual delegations will be managed by a delegate appointed by the national board of directors. The CEO will report directly to the National President and the President of the FOUNDATION OF FRANCESCO TERRONE RIPACANDIDA AND BROOM

ETS for the pursuit of institutional goals.

## Art.11 - The Movement is structured:

Members of the National Assembly which includes ordinary members, founders and fees;

Regional Division, Provincial and Municipal;

National Executive Council consists of a minimum of three members and a maximum of fifteen members which is part of the President, three Vice Presidents, the Treasurer, and Deputy to the coordination of regional delegates appointed by the President of the franchisor foundation and up to nine such directors National Councilors.

Each regional division, such as provincial and municipal representatives will be on the ground by a delegate appointed by the National Executive Council.

Each regional division, provides a regional council said the Regional Council of Peripheral delegates.

The regional council is represented, managed and coordinated by the regional delegate.

The Regional Divisions will be responsible for coordinating the activities of the respective provincial and municipal divisions.

Art.12. - The National Assembly of the members is the crucial moment of confrontation, which would ensure the proper management of the Movement and is composed of all members, each of whom has one vote, regardless of the value of the share. It is convened at least once a year in ordinary and in extraordinary session when necessary or requested by the National Governing Council, by the President or at least one tenth of the members. The first call of the ordinary shareholders' meeting is valid if there is a majority of members, and shall be effective with the majority of those present; on second call the validity irrespective of the number of those present. The extraordinary assembly deliberates in first convocation with the presence and the favorable vote of the majority of members, and on second call the validity irrespective of the number of those present. The summons must be done with the public notice board of the office at least 15 days prior to the Shareholders and the notice of meeting published in a national newspaper. Of the shareholders' resolutions must be publicity to the notice board of the office of the relevant minutes.

Art. 13. - The National Assembly has the following tasks: - elect the National Governing Council, the Board of Arbitrators; - approve the budget and final accounts; - approving the Regulation interno. Ammette members onorari- decides the political direction movement and approves the proposed initiatives. The extraordinary shareholders' meeting decides on amendments to the Statute and the eventual dissolution of the Movement. At the opening of each session, the meeting is chaired by the President, the Secretary shall draft the minutes.

Art. 14. - The National Board of Directors consists of 10 members plus the treasurer who is appointed by the President of the National Council.

Directors are elected by the 'National Assembly of the members except the Coordinator of the regional delegates.

The directors of the National Executive in turn elect the President and three Vice Presidents. The members of the National Executive Council carry out their activities for free and remain in office for five years.

The Board is elected and can be revoked by 'National Assembly by a majority of 2/3 of the members.

Such votes are cast via the platform "Vesuvius"

Art. 15. - The National Council meets on average 2 times a year, is the association's executive body. It is convened by: - the National President; - at least two of the components, on a reasoned request, - justified and written request of at least 30% of members. The National Executive Board has all the powers of ordinary and extraordinary administration. In the ordinary its tasks are: prepare the documents to be submitted to, - formalizing the proposals for the management of the Association; - preparing the final budget, in collaboration with the treasurer, which must contain the individual expenditure items and entry for the period of one year; - preparing the budget, with the collaboration of the treasurer, which must contain, divided into individual items,

Art. 16. - The last national president in office for five year s and is the legal representative of the Move nt. He is elected by the Governing Council and is responsible for all forms of external communication of the Movement. The President is vested with all the powers of ordinary and extraordinary administration. Among other initiatives can promote on the basis of the policy approved by the Assembly and on the purposes set out in this statute. Up to him to the offices of the Movement and the various territorial sections. Art. 17. - The Board of Arbitrators consists of three members elected at the meeting. It lasts three years. He decides unquestionably, within thirty days from the filing of appeal on decisions of expulsion and denial of admission.

Art. 18. - The treasurer has responsibility for the administration of the funds of the Movement and its economic management. He is elected among the members of the National Board of Directors proposed by the President and shall hold office until the election of his successor that can be called at any time by the President after consultation with the National Executive Council. When charging is automatically a member of the National Executive Council. It has the obligation to make available all the records to anyone who requests it. It has the obligation to collaborate with the National Board of Directors for the preparation of the budget and the final budget.

Art. 19. - The Secretary is appointed by the President from among the members of the National Executive Council. Its task is to prepare the minutes of each meeting, regular or special, the Assembly and the National Executive Council. It has to deposit at the headquarters of the Movement all acts respecting the timeframe set by law and these Articles.

Art. 20. - The College of the wise consists of people who have gained a considerable experience in the field of science, culture, economics, social, political, academic and so on.

- Art. 21. The dissolution of the Movement is decided by the extraordinary. The institution's remaining assets must be donated to association with similar purposes or for public purposes, after the monitoring body in art. 3, paragraph 190 of the 12/23/96 law no. 662.
- Art. 22. All elected offices are free. For members only competes reimbursement of various expenses duly documented.
- Art. 23. The non regulated by these Articles of Association is delegated to the approval of the implementing regulation by the National Assembly of the shareholders.
- Art. 24. For anything not covered by this statute apply the existing laws in a way.
- Art. 25 For disputes of any nature, the jurisdiction is the Court of Rome.
